#### VI. WAITING PERIODS FOR RECORD SEALING

Sexually oriented offenses where the offender was subject to registration requirements - 5 years after registration requirements have ended

Pardons - Generally no waiting period

#### VII. WAITING PERIODS FOR EXPUNGEMENT

Minor misdemeanors - 6 months after payout

Misdemeanors - 1 year after final discharge

Felonies of 4<sup>th</sup> and 5<sup>th</sup> degree - 10 years after date on which offender could have filed for record sealing Felony of 3<sup>rd</sup> degree - 10 years after date on which offender could have filed for record sealing Sexually oriented offenses where the offender was subject to registration requirements - as offense can be a misdemeanor or felony, unclear of waiting period for expungement after record sealed

R.C. 2921.43 - soliciting improper compensation - as offense is a misdemeanor, unclear of waiting period for expungement after record sealed

Ignored Cases - there is no provision in the statutes for expungement

Dismissals or Acquittals - there is no provision in the statutes for expungement

Pardons - there is no provision in the statutes for expungement

### JUVENILE ADJUDICATIONS THAT CANNOT BE SEALED OR EXPUNGED

If under the age of 18, application to seal can be filed six months after final disposition. If over the age of 18, there is no waiting period, but all dispositions/court orders must be complete before application can be filed. If sealing is granted, it may be expunged immediately. If expungement is not immediately granted by the juvenile court, sealed charges are expunged automatically after 5 years or at the age of 23, whichever occurs first.
